Mask Rule Changes for Washington State Businesses & Workers

- As of March 12, 2022, masks will no longer be required to be worn in many settings.
- Local health jurisdictions and individual businesses may still choose to require masking.
- Employees can wear masks if they choose to. Businesses can't punish workers who wear a mask, take time off to get vaccinated, or seek treatment for COVID-19.

Assessing COVID-19 Hazards


Masks are no longer required for most workers, however, the COVID-19 pandemic remains a public health emergency and a recognized workplace hazard. Employers must continue to ensure a safe workplace by assessing the amount of disease in the community, how close workers are to others, whether the worker or others they interact with are vaccinated, ventilation etc. and adjusting their prevention measures accordingly.

Prevent Accidents in your Business with an

Every employer in Washington State is required to create a written Accident Prevention Program (APP) to address the safety and health hazards found in their workplace—and not having one for your business is one of the most common reasons a business gets cited by L&I inspectors. Many employers consider their APP as their cornerstone safety program.

Identifying hazards is the first step to creating an APP. Resources, like the Job Hazard Analysis or the Workplace Hazard Basics course, are available to help you with this task. Other tools include program templates that require customizing in order to meet requirements. A Consultant is also available to aid you in writing an APP customized to your business.
